Nature of the Position

The Climate Justice Facilitator is the point person at the parish for matters pertaining to the environment; gathering a group of volunteers together to form a Climate Justice Team and liaising with the parish leadership and Climate Justice Niagara committee to reduce the parish's footprint on the earth and undertake practices which are sustainable and environmentally-friendly.

Outline of Responsibilities

- To liaise (primarily through email) with the diocesan Climate Justice Niagara Committee, in order to facilitate a mutual sharing of information between the parish and the Climate Justice Niagara Committee.
- To gather and animate a 'Climate Justice Team' of parishioners to assist with the work of environmental stewardship within the parish.
- To assess, alongside the parish's Climate Justice Team, the ways in which the parish can minimize its negative impact on creation through the implementation of sustainable best practices for its building and ministry.
- To work with the parish leadership to address areas of the parish life that could be improved upon from an environmental and sustainable perspective.
- To implement a policy for the reduction of single-use plastics in the parish
- Have a working knowledge of the Best Practices and resources as found on the diocesan website
- To help initiate and promote programs that educate parishioners and others about the links between environmental degradation, climate change and the impacts upon societies worldwide, especially the poor, the marginalized and Indigenous people
